<p>Violation #38. Vermin control</p> <p>Repair or replace the air curtain (fly fan) above the kitchen's back door.</p> <p>CODE REFERENCE: Vermin. 64E-11.007(7). Effective measures shall be taken to protect against rodents, flies, roaches and other vermin. All openings to the outside are protected against vector entrance.</p>
